2021 POLOPLAZ SUPER SAND AND FINISH SWEEPSTAKES

OFFICIAL RULES

Important: Please read these Official Rules before entering this Sweepstakes (the "Sweepstakes"). By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES, PURCHASE OR PAYMENT WILL NOT INCREASE ODDS OF WINNING.

Sweepstakes void where prohibited by law. Subject to applicable federal, state, and local laws.

Sponsor's or its designee's computer is the official time-keeping device for the Sweepstakes.
- 3. **How to Enter:** To enter, complete the steps as instructed for either of the following methods of entry during the Sweepstakes Period:
 - a. <u>Purchase Method of Entry</u>: Purchase two pallets of 5-gallon pails (equals 360 gallons) of PoloPlaz Sports coatings directly from Poloplaz, Inc. or through P.A.W. Enterprises, Inc. You will then receive one entry for each eligible purchase of two pallets (360 gallons).
 - b. You will receive one entry for each eligible 3" x 5" postcard received, up to 5 entries per day.

<u>For Each Entry Method</u>: Limit five entries per person per day during the Sweepstakes Period, regardless of entry method. Any attempt to obtain additional entries, including through multiple or duplicate accounts will result in disqualification. All entries must be submitted by the individual entrant. 4. **Identity of Entrant:** If there is a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address submitted with the entry. An "authorized account holder" means the

natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
